Executive Summary

The 2019 Legislative Session was unlike any other in history. O4AD approached the session with a focus on budget – sustaining current budget levels and building the case for meeting the needs of the Medicaid field staffing to meet current needs. The 2019 Session held many unique opporutnities and challenges which had not been seen previously. Oregon Democrats came in with a super majority as well as a Democratic Governor but this did not prevent unexpendeded bumps in the political process.

O4AD, working with advocates, members, stakeholders and other partners, worked to increase the foucs on the need sof Oregon's long-term system of services and supports and increase investment in this area for older adults and people with disabilities. Inreasing advocate engagement, advancing education for new legislators and new committee members and Chairs and working collaborativley with the Aging and People with Disabilities Division of the Department of Human Services resulted in a strong presence in the Capitol.

With the Session now adjourned, we are looking at the successes and identifying challenges that will drive our work in 2020.



2019 Legislative Recap

Oregon's 2019 Legislative Session was guaranteed from the opening gavel to bring an unprecedented amount of issues, angst and heated debate. It did not disappoint.

The Democrats came into the Session with a Super Majority for each chamber. In theory, with this power, the Caucuses would have been able to move virtually any policy priority of their choosing without the need for a Republican vote. However, like so many things in life, nothing is certain until it happens.

In the Senate, Senator Betsy Johnson, long considered the most moderate of the Caucus and frequently voting with Republicans, gave no indication that this perspective would change. However, Senate President Peter Courtney made an unusual move and granted the Senate Chairmanship of the Joint Committee on Ways & Means to both Senator Johnson and Senator Elizabeth Steiner-Hayward. In what is often considered the most powerful Committee position that may be given, the Senate "Co-Co-Chairs" would each have an equal voice in the development and passage of all budgets and fiscal requests for the Legislature. Pundits wondered if giving Senator Johnson the gavel in this position would then give the caucus assurances of her vote in a number of high-profile priorities that the Senator generally would oppose including revenue raising and lowering tax credits.

Joining the Senate Co-Co-Chairs in Committee leadership – and thus creating the "Tri Chairs" - was Representative Dan Rayfield. Representative Rayfield, considered a rising star in the Caucus, was named the House Co-Chair close to the start of session in a surprise to many in Oregon's political world. Representative Nancy Nathanson, who had served as House Co-Chair previously, was moved to Chair of the House Revenue Committee.

The "Tri-Chairs", as they were dubbed, had the large task of developing all budgets for agencies and other priorities under a never-before-seen leadership structure.

Coming into the 2019 session, Democrats were consistent in their priorities which included – paid family leave, education revenue package, cap and trade/carbon emission limits and environmental protections, and housing. The Governor also stated her priorities to include sustainable funding for the Oregon Health Plan paired with increasing the tobacco tax to support the Health Plan, cap and trade, addressing housing and homelessness and making a record-breaking increase in K-12 education funding at \$2 billion. Her budget, released in December 2018, provided many investments in a variety of areas but was also predicated on potential revenue increases from provider taxes (health care), corporate taxes, tobacco and potentially alcohol taxes and other fees along with limitations on tax credits and expenditures.

The Legislature was successful in implementing many of these proposals. A corporate tax was passed which will result in the \$2 billion K-12 education investment (HB 3427). This tax passed with limited corporate support and some major players in previous opposition efforts carved out of the tax package. The bill passed the House on party lines but resulted in the Session with the Senate Republicans walking out to delay a vote on the tax package. To bring back the Senate Republicans, other priorities of the Democratic caucus including gun control bills, were shelved. Ultimately, HB 3427 did pass the Senate, also on a party line vote.



The Speaker shepherded a tenant rights/rent control bill through in the beginning of session, a first in the nation with action at the statewide level. However, the proposed "cap and trade" bill, HB 2020, suffered at the hands of political maneuvering. The bill original passed the House on a party line vote but a second walkout by the Senate Republicans stalled the bill in the closing days of session, ultimately causing its demise.

HB 2270, the proposal to increase tobacco taxes to support the Oregon Health Plan, was passed during the end of session and will go to voters. A proposed ballot measure to overturn the corporate tax passed to fund education was discussed and, should it be successful in making it to the ballot, will be voted on during a special January 2020 election. Other continuing discussions on unsuccessful measures going to ballot have included cap and trade and gun control. The Governor and Senate President have indicated that action on cap and trade is the highest priority and we expect more action on this during the interim.

During this Session, the Legislative body also said goodbye to two long-time public servants. Secretary of State Dennis Richardson and Senator Jackie Winters both lost their battles with cancer and were celebrated with services in the building. Subsequently, appointments were made to fill their offices: Former Speaker of the House Bev Clarno was appointed by Governor Brown as Secretary of State and Representative Denyc Boles was appointed to the Senate.

The Legislature will begin their interim work in September when committees reconvene for Legislative Days. The 2020 Legislative Session will convene in February 2020.

O4AD Priorities for 2019

Coming into the 2019 Legislative Session, O4AD identified the following Legislative priorities:

Current Services Budget – maintaining current service level for programs including – Oregon Project Independence, Medicaid long-term services and supports, Evidence Based Mental Health, Options Counseling, Older Americans Act Support and Evidence Based Health Promotion and Disease Prevention.

Medicaid Case Management – seeking support for additional positions given the dramatic underfunding and understaffing that is impacting service delivery. Increased workload demands were identified as a key issue for the 2019 session. The Aging and People with Disabilities Division (APD) submitted a Policy Option Package which would have brought staffing within case management to 100% of the workload model. Unfortunately, this was not included within the Governor's Recommended Budget.

Oregon Project Independence Expansion via Federal Match – seeking budget note to direct the Oregon Health Authority and Department of Human Services to research a demonstration waiver to allow for potential Federal Match to expand Oregon Project Independence to Medicaid eligible individuals



O4AD's work prior to the session focused on drawing attention to the issue of workload within the field structure of APD (Aging and People with Disabilities). Area Agencies that are handling the Medicaid caseload in Oregon comprise over 50% of the total caseload served by the State. Oregon continues to see growth in the older adult population which has translated into higher demand for long-term services and supports. This growth trend is forecasted to continue on into the future.

The release of the Governor's Recommended Budget (GRB) indicated support from the Executive Branch for preserving services at current service level. This early signal came with a huge sigh of relief from Area Agencies and advocates. After many biennia of proposed cuts, reductions or eliminations of programs in the Governor's budget, a proposal that would retain programs offered an optimistic approach for O4AD leading into the session.

Preparing for the Session, O4AD continued our participation in the campaign season as well as post-election support to Legislators. With a high number of new legislators coming into the building, education about the aging and disability services network and role of Area Agencies was the focus of pre-session meetings, along with support from Advisory Councils and advocates around the state.

O4AD hosted advocacy training prior to the beginning of the Session. Our popular Advocacy 101 and Legislative Bootcamp trainings were filled with advocates interested in learning more about the legislative process and engagement. O4AD holds a strong philosophy that there are many ways to be engaged in the legislative process and our goal is to make the process as accessible as possible to increase advocacy. We have been pleased with the response to these trainings and plan to continue these offerings into the future.

O4AD maintained our involvement with various coalitions including HSCO – the Human Services Coalition of Oregon, The Campaign for Oregon's Senior & People with Disabilities, Older Adult Behavioral Health Advisory Group, various DHS/APD workgroups and individual meetings with stakeholders regarding their legislative priorities.

2019 Legislative Outcomes

<u>HB 5026</u> – DHS Budget Bill. As the Legislature completed their work, the DHS budget bill was released. HB 5026, bill, which covers all programs and services within DHS, is the overall funding bill for all of the Department of Human Services. For the 2019-21 biennium, the Ways & Means Co Chairs proposed several investments in programs and services:

- \$270,000 to implement HB 2600, which requires DHS to conduct annual inspections of care facilities' kitchens and food preparation areas
- Increase in rates for Assisted Living Facilities, Residential Care Facilities, Memory Care Facilities and In-Home Care Agencies serving Medicaid consumers
- Increase in rates for Providence ElderPlace
- Increase in rates for Adult Foster Homes serving Medicaid consumers
- Increase in community-based care surveyors
- Increase of 143 positions to Area Agency and APD offices to begin addressing workload issues within case management. These positions are slated to be implemented for half of the 2-year biennium.



The DHS budget also included funding for Current Service Level in the following programs:

- Medicaid long-term services and supports
- Oregon Project Independence serving older adults
- Oregon Project Independence Pilot Project serving younger people with physical disabilities
- Evidence based mental health programs
- Options Counseling through the ADRC (Aging and Disability Resource Connection)

However, there were also proposed reductions within the APD program area. These included:

- Elimination of funding for Evidence Based Health Promotion and Disease Prevention programs \$1.3 million
- Elimination of funding to support Older Americans Act programs \$2.2 million

HB 5026 also included budget notes which would impact programs and services:

- DHS has been directed, for the 2021-23 budget cycle, to request budget bill appropriations at a more detailed level than presented in HB 5026. Appropriations are directed to be established within the individual programs including APD.
- DHS and the Oregon Health Authority have received direction to begin investigating the potential to apply for a Federal Demonstration Waiver to bring matching funds to the Oregon Project Independence program to expand services to Medicaid eligible individuals.

O4AD worked closely with advocates, stakeholders and key legislators to restore proposed reductions in funding. The goal was to see restoration in the "Christmas Tree" bill for those reductions.

<u>HB 5050</u> – End of Session Budget Reconciliation Bill. This bill, informally referred to as the "Christmas Tree Bill" contains end of session appropriations indicated by the Ways & Means Co-Chairs. There were various adjustments which impact programs and services for older adults and people with disabilities:

- \$2.2 million restored to support Older Americans Act programs, which had been eliminated in the DHS budget bill
- \$1.3 million restored to the Oregon Food Bank via the Oregon Hunger Response fund to allow the network of food banks to maintain their 2017-19 funding level.
- \$1.5 million for the Double Up Food Bucks program, to incentivize fruit and vegetable consumption among individuals receiving SNAP (Supplemental Nutrition Assistance Program) benefits.

A number of other bills were also passed which impact services and supports to older adults and people with disabilities ~

<u>HB 2587</u> – This bill allows individuals who wish to participate in the Senior and Disabled property tax deferral program who have a reverse mortgage to be considered for eligibility in this program.

<u>HB 2601</u> – This bill limits a guardian's authority to limit protected person's preferred association with third parties.



HB 2999 – This bill allows for a temporary duplicate disabled parking permit to be renewed by mail.

HB 3413 – This bill authorizes the Office of the Long-Term Care Ombudsman to hire up to 10 deputy ombudsmen.

<u>SB 31</u> – This bill permits the Oregon Public Guardian and Conservator to establish county, regional and statewide high-risk teams to identify options available for addressing safety risks facing highly vulnerable adults.

<u>SB 608</u> – Prohibits landlord from terminating month-to-month tenancy without cause after 12 months of occupancy.

<u>SB 729</u> – This bill modifies the Elderly Persons and Persons with Disabilities Abuse Prevention Act to apply to elderly persons who are residents of long-term care facilities.

<u>SB 770</u> – This bill establishes the Task Force on Universal Health Care, charged with recommending the design of a Health Care for All Oregon Plan. Within this work, a specific advisory committee is to be established to look at Oregon's long-term services and supports in conjunction with universal health care.

<u>SB 889</u> – Establishes the Health Care Cost Growth Benchmark program to control the growth of health care expenditures in this state.

Looking ahead

O4AD applauds the significant investment in Medicaid case management by the 2019 Legislature. This investment was a critical priority for O4AD and will lead to important workload relief. We will continue to work with the Aging & People with Disabilities Division as they complete an updated workload study. This study, which measures the amount of work that is required to provide Medicaid services, will inform not only DHS and Area Agencies, but also the Legislature on the appropriate levels of staffing necessary to meet the demands of current services.

O4AD works through our member asgencies to determine our Legislative priorities. However, our mission to protect the independence, dignity, choice and safety of Oregon's older adults remains at the forefront of our work.

We wish to thank all of the advocates, stakeholders and our members for their continual engagement during the Legislative session. Their work and advocacy remains the foundation of our legislative work. Each of our partners tells a different perspective of the need to prioritize long-term services and supports for older adults and people with disabilities. We look forward to continuing this work into the 2020 Legislative session.
