Says what must happen if a public agency ends a contract for goods or services and a new company takes over. Says that the new contract must have a health plan as good as or better than the health plan in the old contract. Says the new contract can do this by joining a labor union's health plan or giving benefits as good as those in the Oregon Health Plan. (Flesch Readability Score: 64.0). Requires that qualified nonprofit agencies for individuals with disabilities employ individuals with disabilities for not less than 50 percent of the work hours of direct labor required for manufacturing or providing products or services.
