People want to age where they choose, be treated with dignity and maintain their independence.



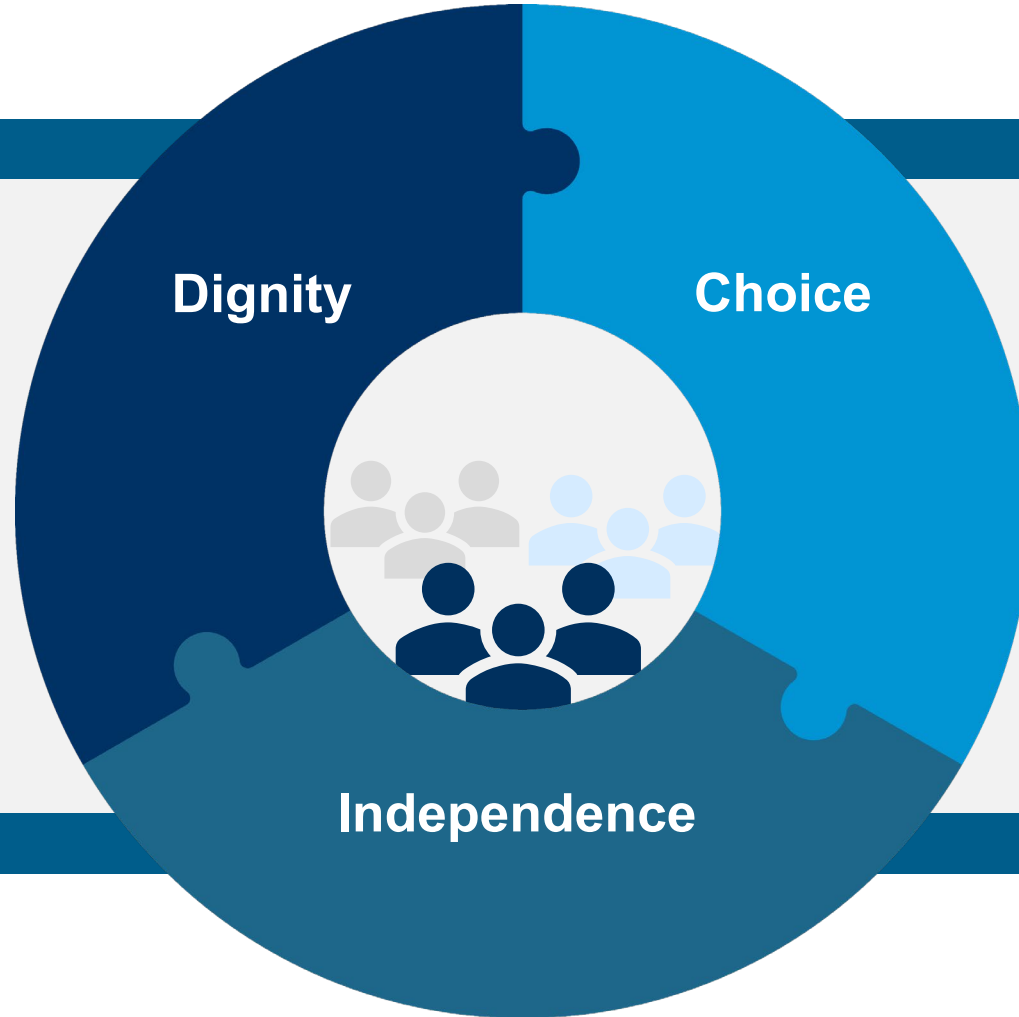
Access to critical and timely services and supports is essential.

# What we do: core services

---

**Set policy** for Medicaid eligibility, services, rates and Older Americans Act.

**License and oversee** long-term care providers.

**Determine eligibility** for:

- Long term services and supports (LTSS)
- Social Security Administration disability benefits
- General Assistance.

**Partner with:**

- Oregon Eligibility Partnership (OEP) and Self-Sufficiency Programs (SSP) to ensure access to SNAP and Medical
- Office of Developmental Disabilities Services (ODDS) to ensure Medicaid LTSS services meet federal regulations.

# What we do: core services

---

Provide service options to **promote choice and independence.**

**Connect people** to homecare services and help people find the right provider.

**Prevent, investigate and mitigate** abuse.

Family caregiver supports, nutrition, legal services and more.

Provide **in-home supports** for individuals who do not receive Medicaid.



# What we do: core services

---

Offer free **information and referral** and **options counseling services**.

Provide **navigation and advocacy** for individuals with brain injury.

Provide **resources** for Deaf, DeafBlind and Hard of Hearing people.

Provide free and impartial **Medicare benefits counseling**.

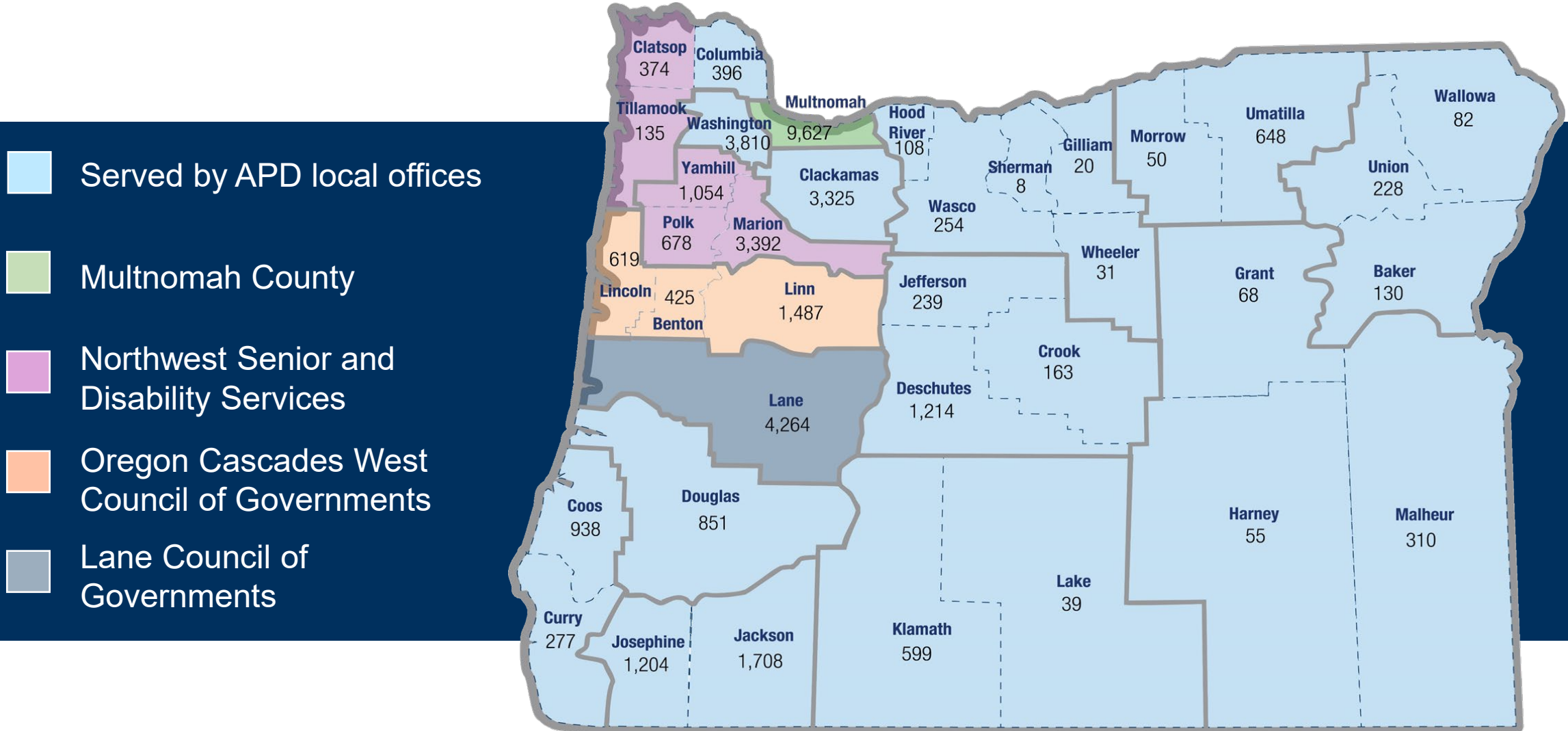

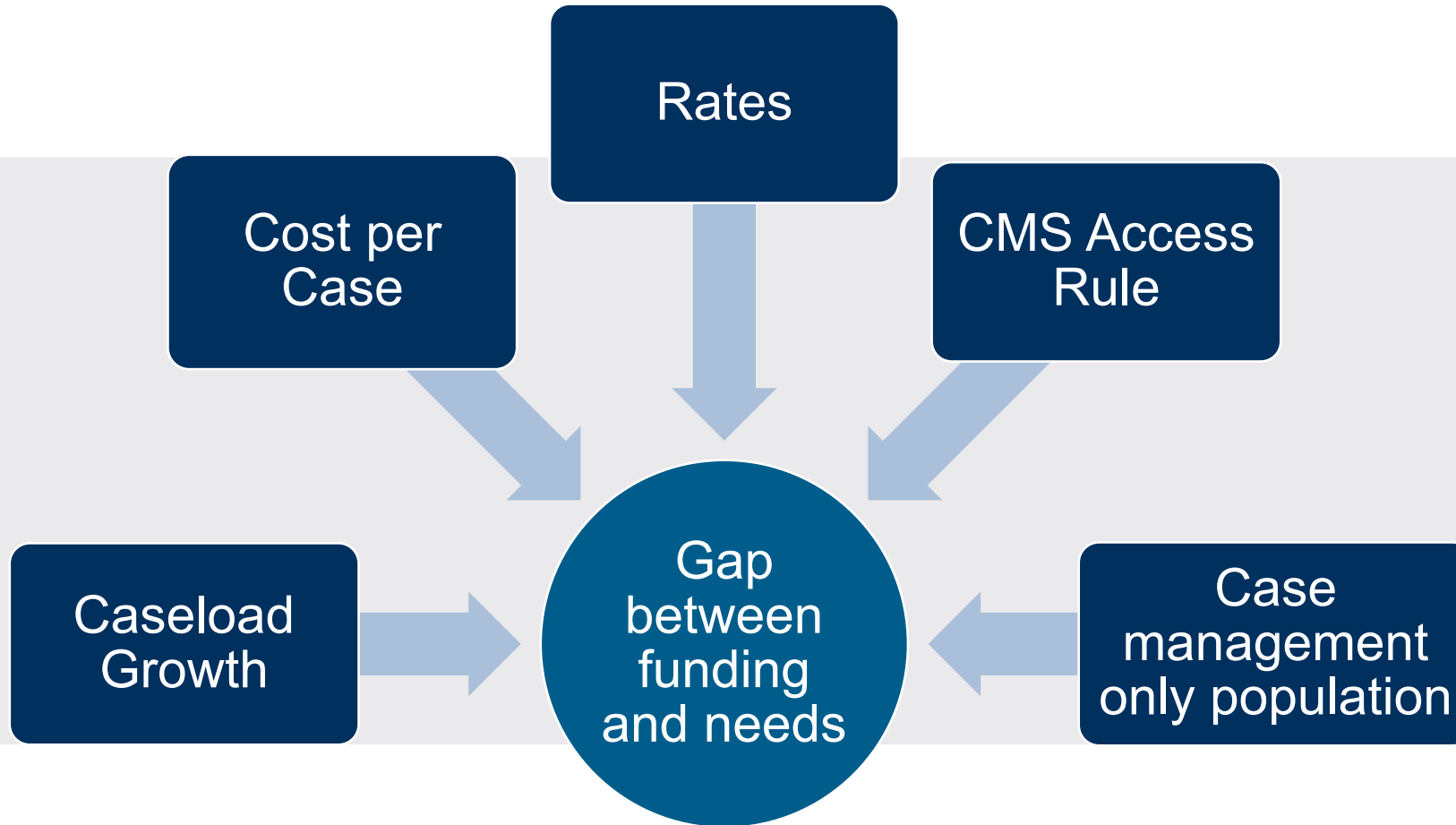

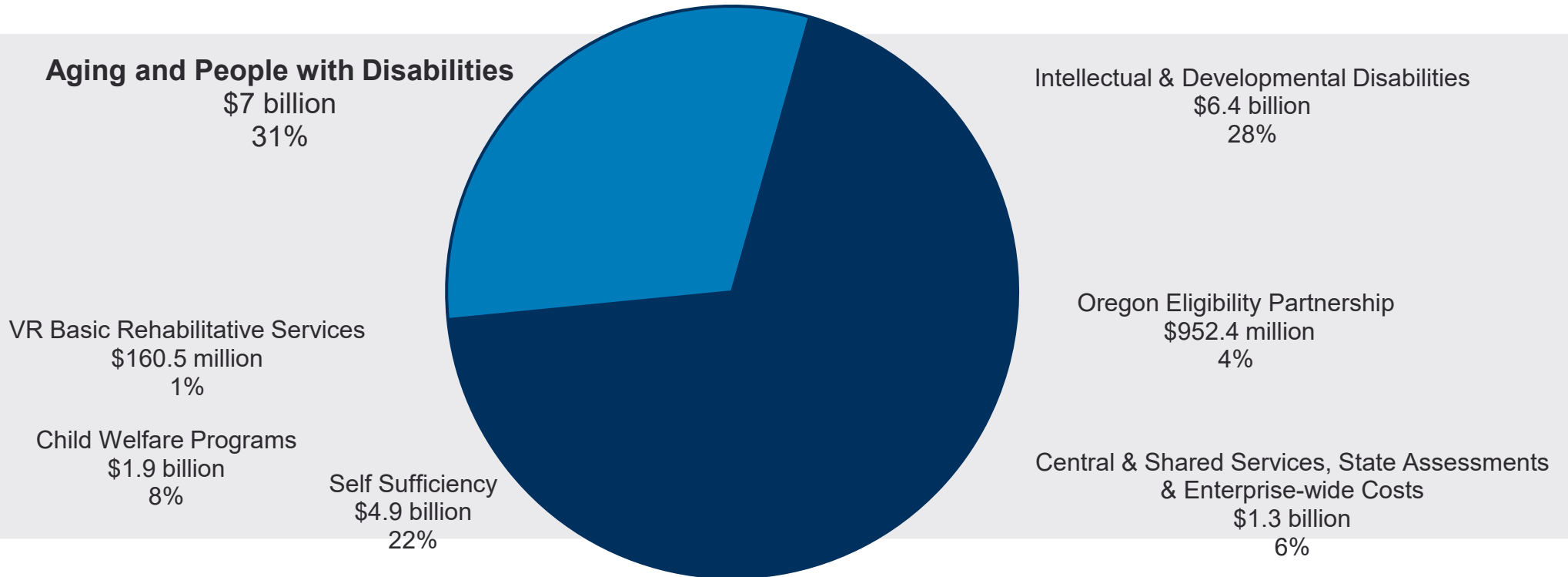

---

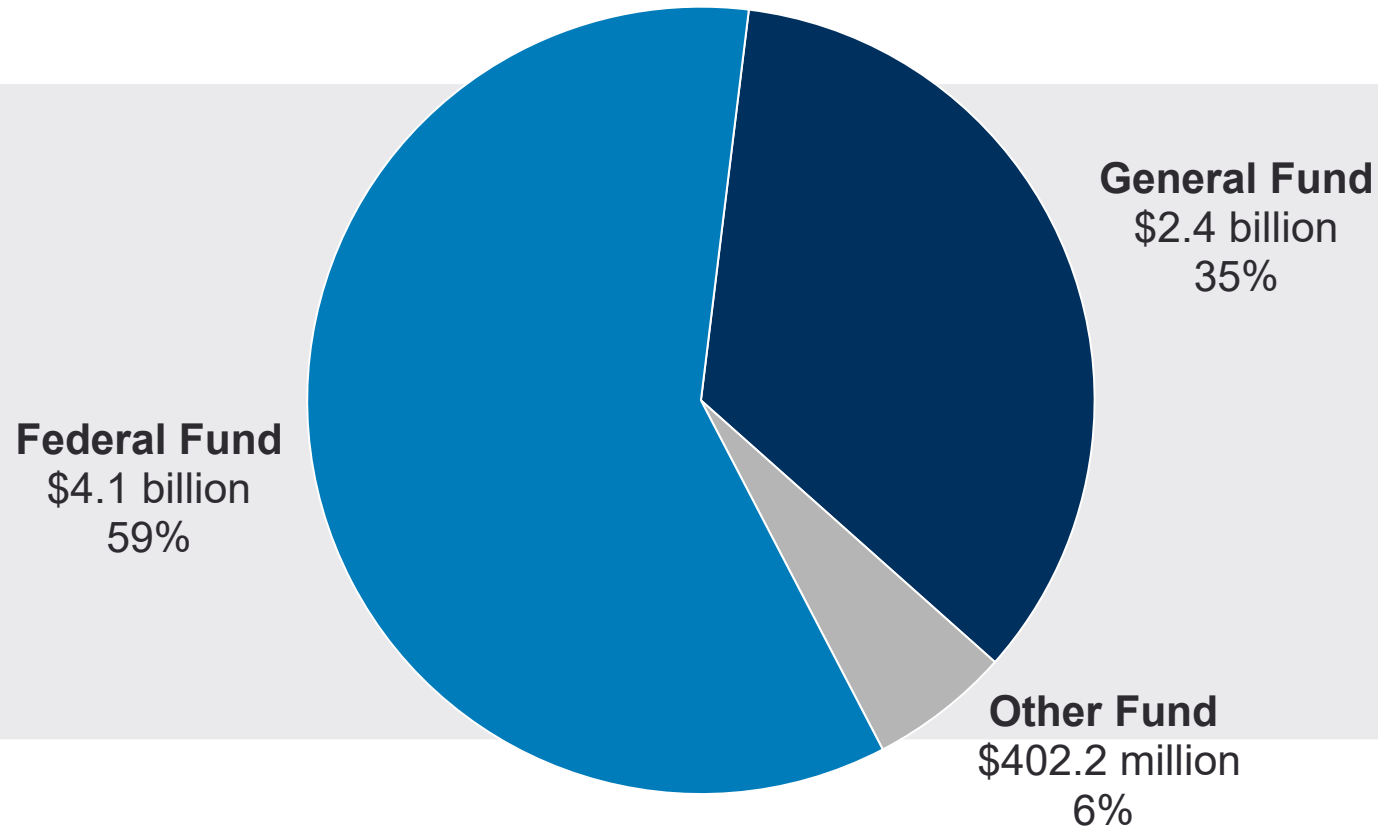

---

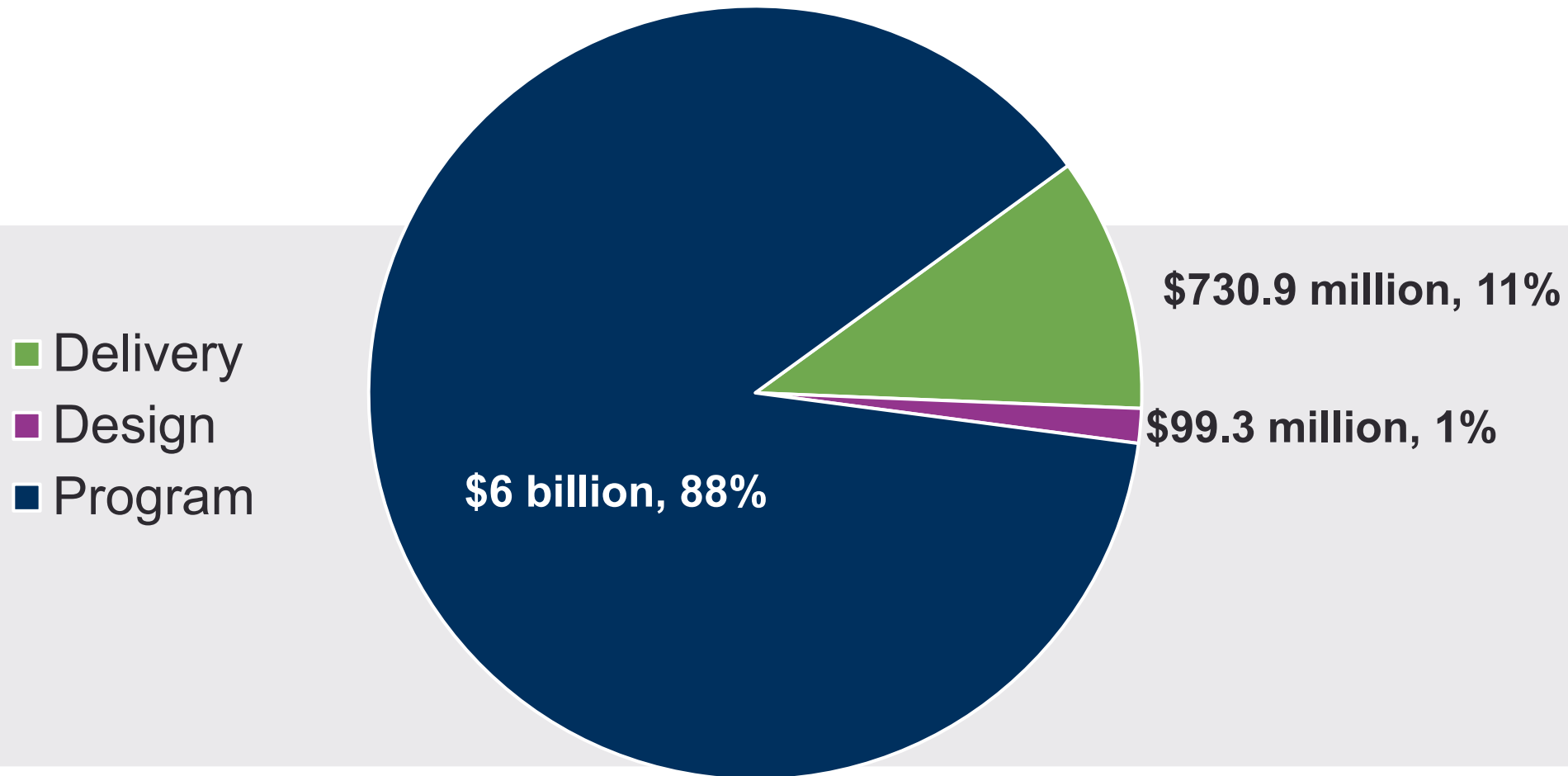

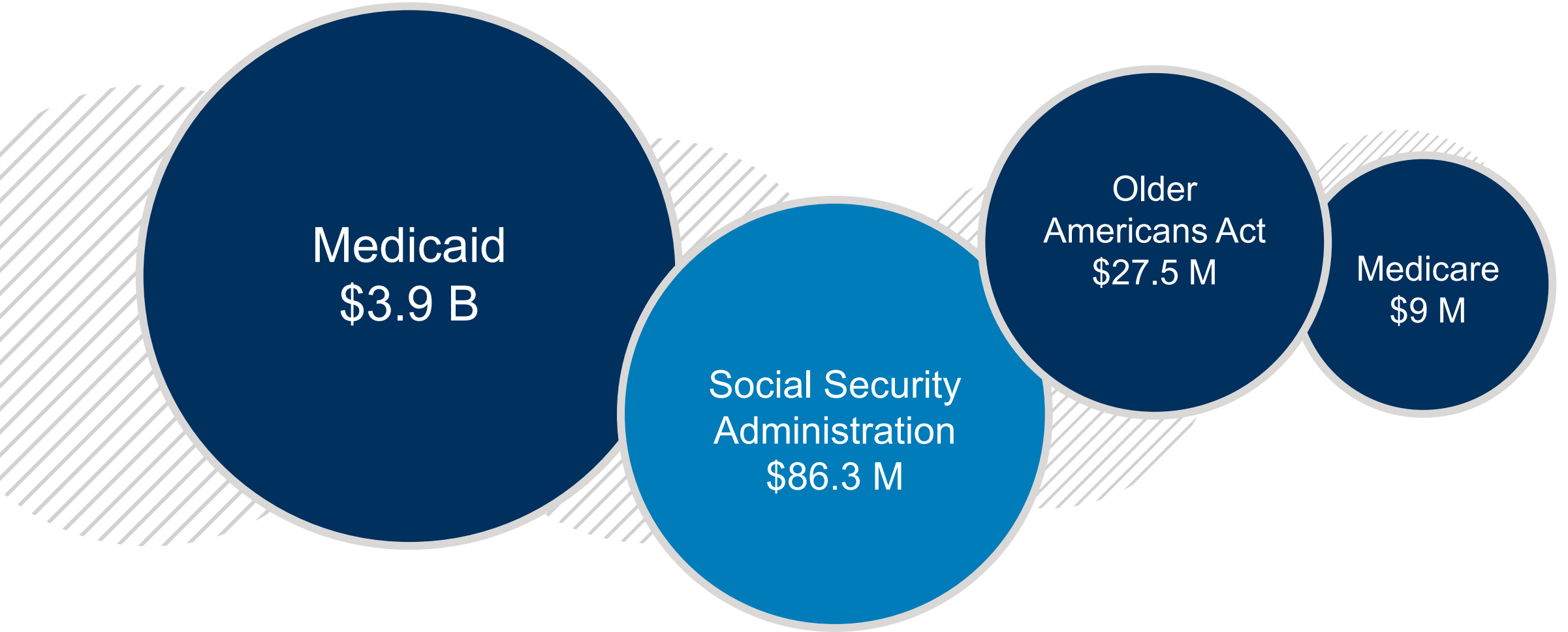
# Budget explanation: budget by category

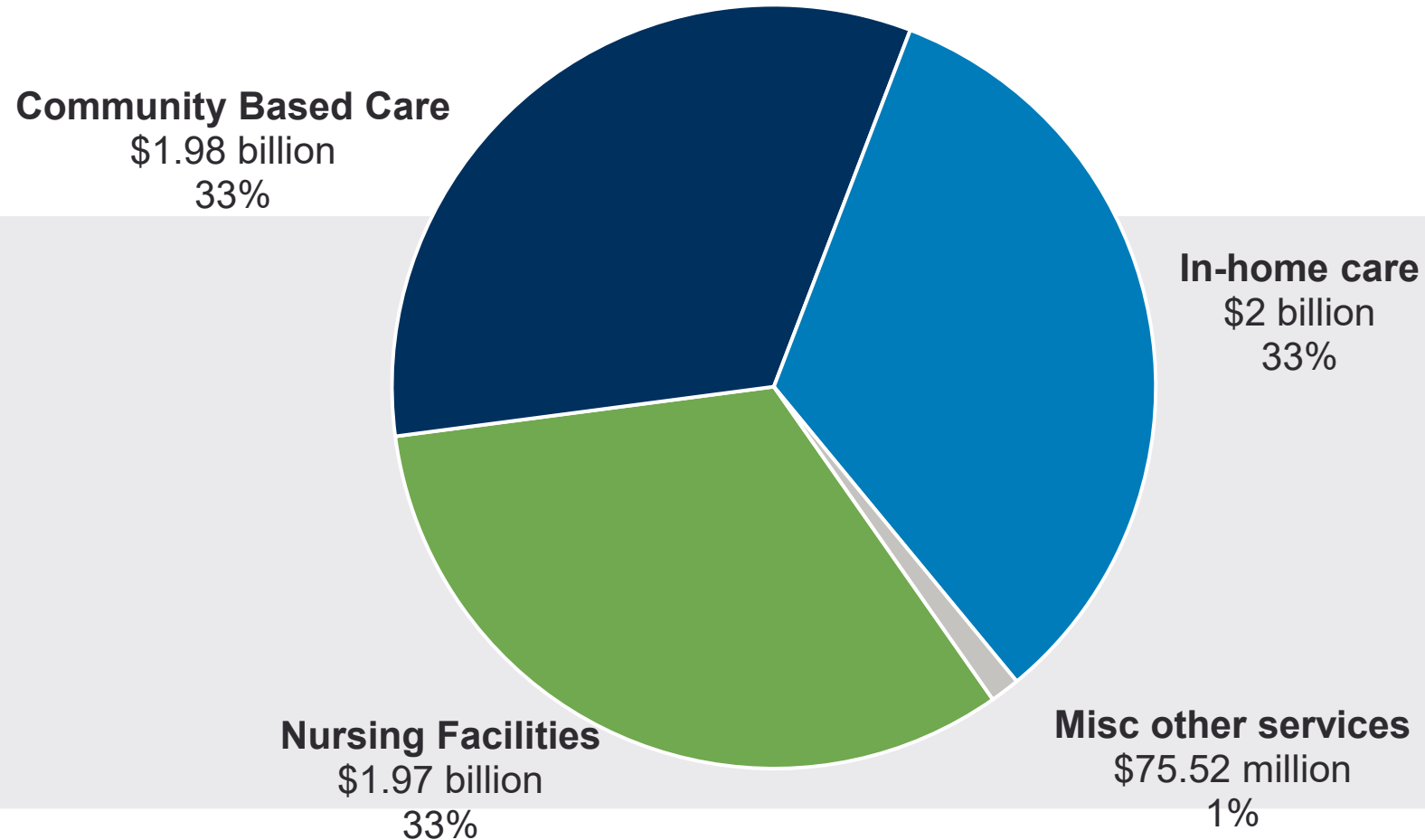

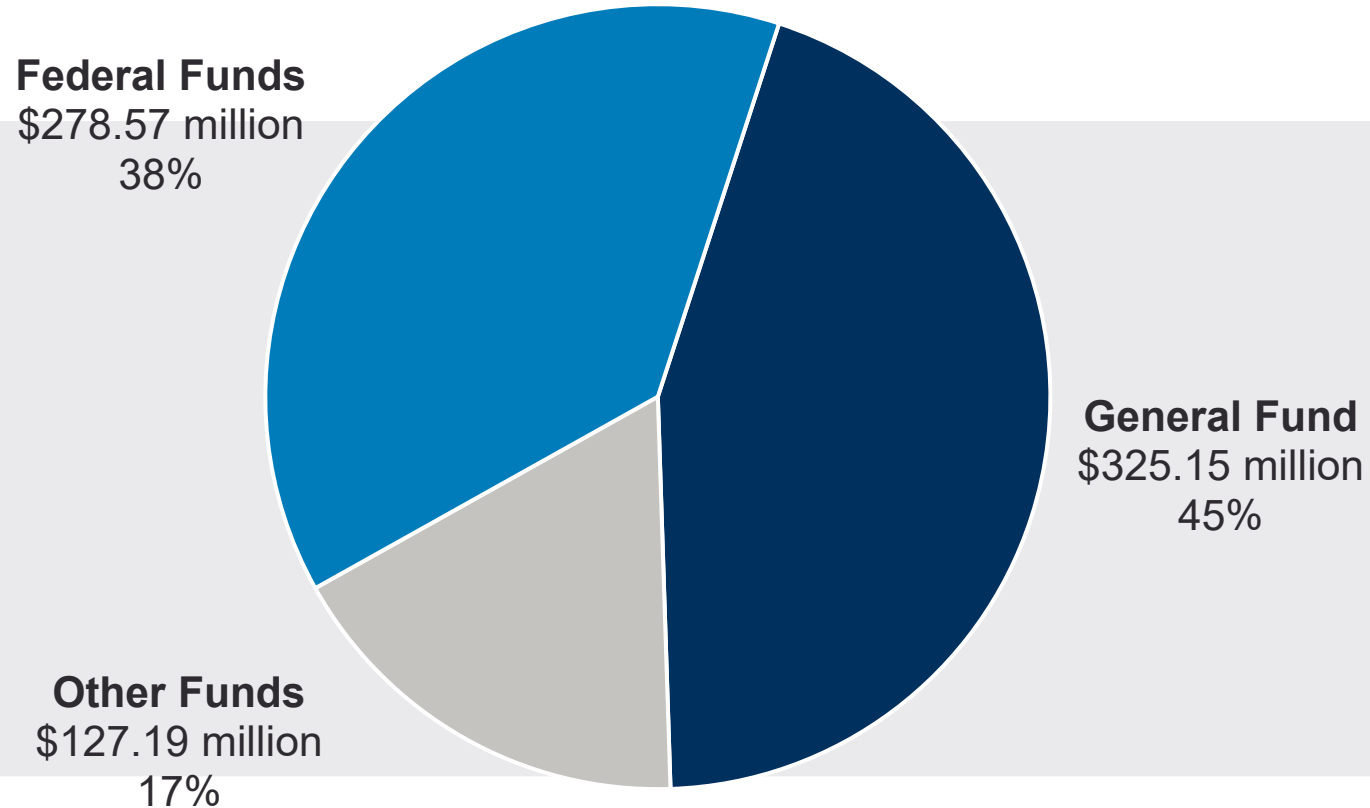

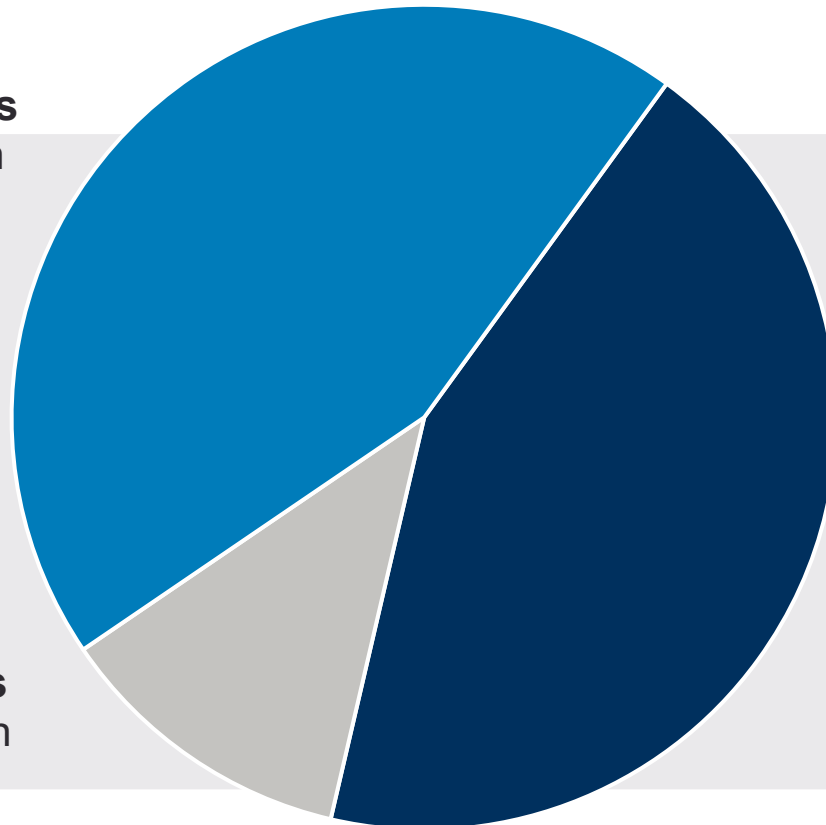

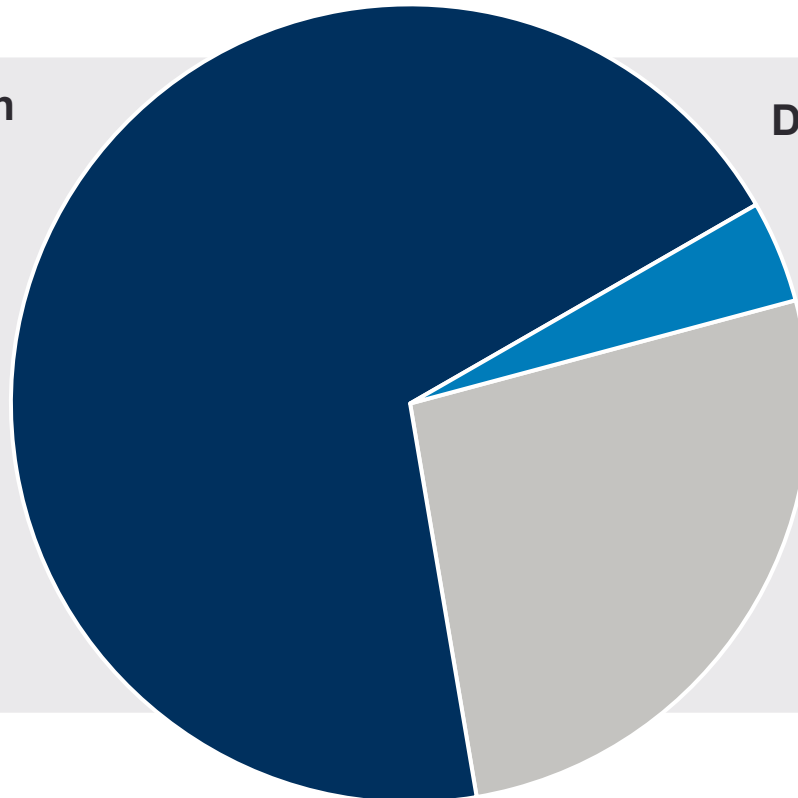

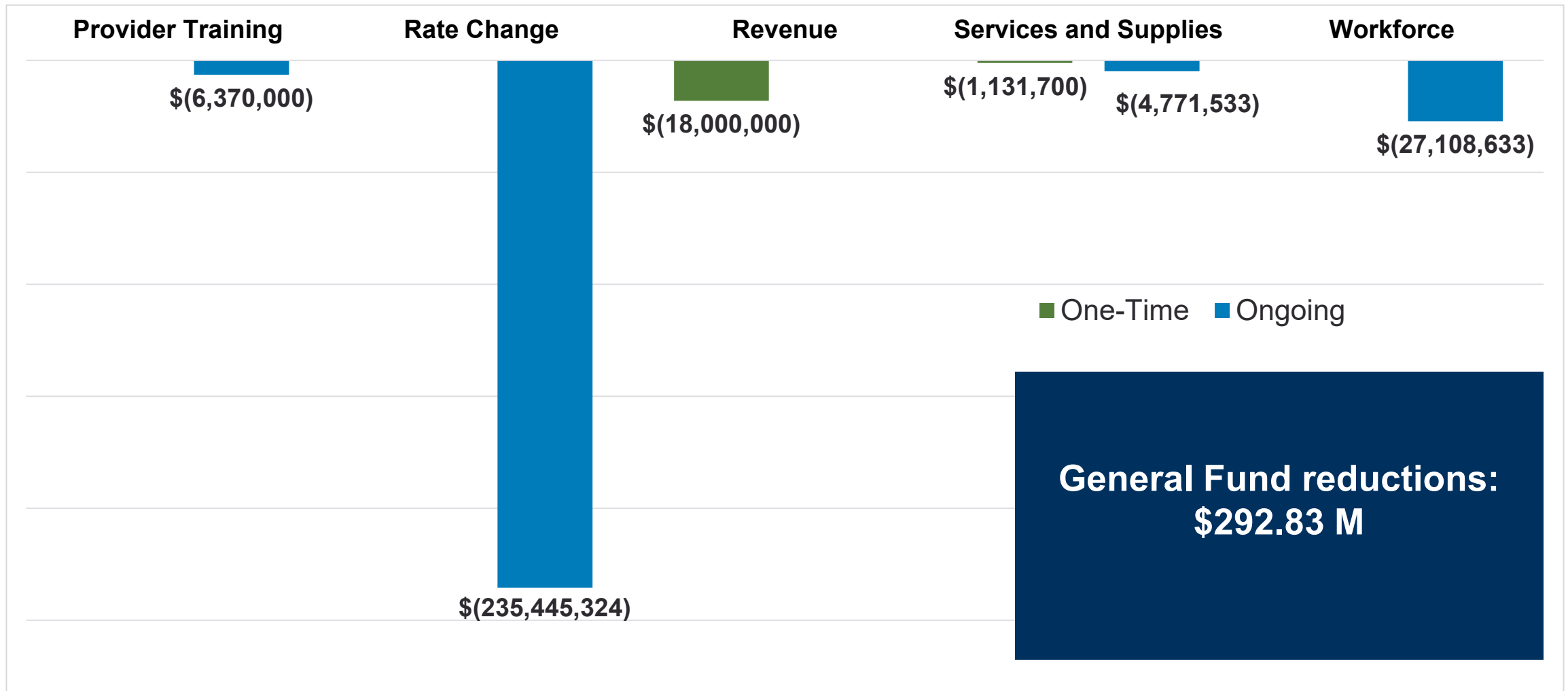

## KPM #1: Older Adults Needing Long Term Care Services

- APD has exceeded the target for many years

## KPM #2: Long Term Care Recipients Living Outside of Nursing Facilities Safety in Oregon's licensed

- APD has exceeded the target for many years

## KPM #3: Timely APD Abuse Investigations

- APD has exceeded this target in the last year

# Proposed new and revised KPMs

---

- **Timely eligibility determinations for APD long-term services and supports**
  - The percentage of older adults and people with disabilities who receive timely LTSS eligibility determinations. Target - 90%
- **Accessibility of APD long-term services and supports**
  - Percentage of eligible older adults and people with disabilities who receive assistance from paid caregivers. Target - 90%
- **Safety in Oregon's licensed Long-Term Care Facilities**
  - Percentage of Long-Term Care Facilities without Level 3, 4 or Immediate Jeopardy (IJ) licensing violations. Target - 90%
- *Language Modification* - **Timely APD abuse investigations** -
  - “The percentage of abuse investigations that are initiated timely”. Target – 95 %

# Key changes and budget impacts: 2019-2025

---

## 2019-21

- Tribal Navigator Program started
- Supported long-term care facilities and adult foster homes during COVID-19
- Worked with local public health to ensure vaccine access to APD consumers
- Assisted hospitals with delayed discharges due to COVID
- Staff began remote eligibility determinations and service delivery

## 2021-23

- 1115 Medicaid Waiver application for OPI-M submitted
- Provider Time Capture: phase 1 implemented
- LGBTQ+ older adult survey
- Acuity-based Staffing Tool implemented
- Housing Support Services created
- Created Crisis Support Services
- Distressed Provider Relief Fund expended

## 2023-25

- Rate & Wage Study
- Oregon Project Independence-Medicaid started
- Provider Time Capture: phase 2 implemented
- SB 99: LGBTQIA2S+ Bill of Rights & provider training
- SB 420: Oregon Brain Injury Program launched
- HCBS Investments continued:
  - Infrastructure & services
  - Workforce
- HB 4129: Agency with Choice implementation began

# Implementation updates: 2023 and 2024 Legislative Session Directives

---



**Senate Bill 99:** Creates an LGBTQIA2S+ Subcommittee of the Governor's Commission on Senior Services, a bill of rights protecting LGBTQIA2S+ residents in long term care facilities and adult foster homes, and mandated training for staff in these settings.



**Senate Bill 420:** Creates the Oregon Brain Injury Program, implementation in 2024.



**House Bill 4129:** Requires that APD contract with up to two Agency with Choice providers no later than January 1, 2026, with implementation work currently underway.



**House Bill 3396:** Created the Task Force on Hospital Discharge Challenges.

# Implementation updates: 2023 and 2024 Legislative Session Directives

---



**OPI-M:** Expands OPI program to serve more consumers, eliminate waitlists, and exempts consumers from estate recovery. Rolling implementation started in June 2024, and full implementation in 2025.



**Rate and Wage Study:** Recommendations to create greater parity in the rate structure, accountability for direct care worker wages.



**Home Care Collective Bargaining Agreement:** A CBA for Home Care Workers, including a \$20/hour wage minimum by 2025, \$1/hour raise for each 2,000 hours worked, and up to 20 hours of overtime a week.

# Implementation updates: 2023 and 2024 Legislative Session Directives

---



**HCBS Spend Plan:** ARPA funding for several initiatives, including capital infrastructure improvements for long term care facilities, provider recruitment, direct care workforce training, and social isolation and loneliness prevention.



**Acuity Based Staffing Tool:** Additional staffing to support the implementation and administration of ABST requirement for long term care facilities.



**Housing Support Services:** An investment in APD Housing Navigators to assist Medicaid Long-term Services and Supports consumers who are housing insecure in every area of the state.

# Policy Option Packages



# POP 101: Strengthening Safety and Oversight



**ODHS priority: Safety**



## Problem:

New licensed facilities and homes do not have timely oversight and support.



## Solution:

Onsite visits, technical consultation and support 120 days after newly-licensed settings open.

SB 811 would support this work.



## Outcomes:

- Proactively identify compliance issues and corrective action steps early, before they present as significant compliance issues.
- Technical assistance to assist new providers to be successful.
- Ensure the health, safety, and well being of residents living in newly licensed long term care settings.

## Data

In 2023, APD triaged 10,931 concerns reported by various partners and community members, a growth in part driven by new and inexperienced providers.

# POP 103: HCBS Access Rule



**ODHS priority: customer service**



## Problem:

New federal regulation outlines significant changes for state to meet transparency and outcome requirements.



## Solution:

This investment provides the staffing and resources bringing Oregon into compliance and maintaining compliance long term.



## Outcomes:

- Regulatory compliance ensures continued federal matching funds for home and community-based services.
- More resources for consumers to express grievances and for the state to track outcomes of long term services and supports.
- Greater transparency in provider rates and Medicaid funds going toward direct care worker pay and benefits.

# POP 560: Ensuring Access to Services for Individuals with Behavioral Health Conditions

 **ODHS priority: Statewide initiatives**



**Problem:**

Since the 1980s, due to federal regulations, APD has not served adults under the age of 65 whose primary driver of need is a mental health or substance use disorder condition.




**Solution:**

Investment would remove this barrier, providing eligibility for individuals experiencing a mental health or substance use disorder condition.



**Outcomes:**

- Individuals with behavioral health conditions would be able to access long term services and supports more quickly, without having to face additional barriers.
- Investment would allow for recruitment and retention of case management and providers trained to serve adults with behavioral health needs.

 **Data**

APD has denied more than 240 individuals in one year (2023-2024) because of their mental illness.

# Additional GRB investments

---

## APD Adult Foster Homes Rate Restructure

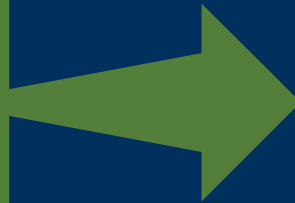
Supported by HB 2560

### Investment:

\$21,367,294 GF

\$38,076,068 FF

**\$59,443,662 TF**



### Changes:

- Payments based on the acuity of each resident
- Reduce the need for rate exceptions by 82 percent
- Increases rates for most providers; no decreases for any provider.

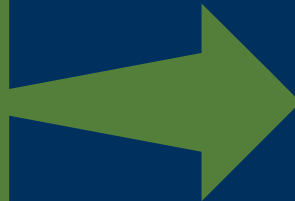
## Homecare Worker bargaining pot

### Changes:

Sets Special Purpose Appropriation for wages and benefits for Home Care Workers and Personal Support Workers.
